Home School Agreement

Our Family will:

- Provide school medical staff with information about our child's medication and health care and to label medical items with name , date, and dosage
- Make sure that our child attends school on time every day (8.55am) and reaches 95%+ attendance, and we will inform school before 9.00am if they are to be absent
- Make sure if our child has an appointment in the morning, we will make sure they come to school after the appointment. If our child has an appointment in the afternoon, we will send them to school and collect at the appointment time
- Accept 'home tuition' when our child is absent for 5 days or more due to illness, to allow education to continue and a phase return to be planned
- Not take our child out of school during term time
- Work with school to help achieve the Individual Targets and where appropriate adhere to Moving & Handling plans, Individual Behaviour plans and Care plans
- Send our child to school relaxed, having had breakfast, a good nights sleep, refreshed and ready to learn
- Attend parent meetings, annual reviews and other school events in order to get to know about our child's life in school
- Keep school informed about things at home that may affect our child's behaviour, learning and attendance at school
- Ensure that our child wears suitable clothes and comes to school in a clean nappy or underwear
- Label all items coming into school, such as any clothes , bags etc, with our child's name, send in nappies, bibs and swim wear etc
- Label money or other items with name, and date, amount and purpose
- Support the school by promoting respect for others and a positive outlook towards school life
- Help our child to make the most of what the school has to offer , such as after school clubs and home work

- Safeguard your child and follow procedures
- Produce an annual report for your child.
- Encourage your child to care for the environment.
- Write Individual Education Plans which are shared with parents/carers/your child and revised regularly
- Work with the Local Authority to ensure safe, effective transport
- Work in partnership with parents/carers so that your child reaches their full potential in all areas of their school life
- Seek high standards through encouragement and rewards for positive behaviour and achievement
- Provide a range of opportunities for learning so that we meet the needs of your child and ensure that they have full access to a broad and balanced curriculum
- Provide regular information about events and your child's progress and opportunities to exchange information
- Ensure that all policies and procedures are put in to practices and are accessible for all parents and carers and your child
- School will monitor your child's attendance weekly and keep you informed if their attendance falls below 90%
- Offer you 'home tuition' to your child if they are off school for 5 days or more due to illness.
- Will work the family to encourage and support good attendance (95%+)
- Visit you at home (if needs be) to support school attendance.
